The question now is : who dropped my name in this saga since none of the Ghanaian parties mentioned knew me or are acquainted to me ? Is have very big friends in Ghana . This is not what they do . They are in mining, oil and gas and real estate . How cheap ! The other question is who dropped Mwana Africa's name , a company focused on DRC , South Africa and Zimbabwe in this dirty story ? The third question is who knew of my connection to both EER and to Mwana Africa and the fact that I brought the two companies together in an alliance to go after oil assets in Angola and Sudan and the fact that alliance immediately enabled EER , who had been struggling for finances , to raise \$35 millions from the same investors who had invested in Mwana Africa after its successful market flotation in London ? Is that why my name came out as someone who could get things done and that I could help BA in Ghana ? I would go to the bush in Ghana to pay off unsuspecting tribal chiefs and take a 10 percent cut in the process ? What an insult? . Your guess is as good as mine as to who would have that inside information about me .

I thank you for inviting me to attend your law suit as a witness . Regrettably I cannot attend . I do not see what purpose it will serve for me personally . Of greater interest to me would be a suit against Diligence who manufactured these reports in the first place , in a London court.
